

Five Year Warranty

Senator Boats 2017 Ltd warrants that, under normal conditions and non-commercial use, each new boat hull to be free from faulty workmanship and materials for a period of 5 years, with exception of all upholstery and windows, being 2 years. During these warranty periods any authorised repairs will be completed free of charge at Senator Boats premises or by an authorised Senator repairer. Delivery costs to and from the authorised repairer is the responsibility of the purchaser. This Warranty is transferrable if boat is on-sold (Only if Senator is advised of new ownership detail to update warranty registration card).

Exceptions to this Warranty

This warranty shall become void if:

1. Any boat has been altered or repaired. This includes the fitting and gluing of carpets and linings, without previous authorisation of Senator Boats 2017 Ltd.
2. Damage resulting from motors and accessories being installed or fitted incorrectly.
3. Any boat that is not loaded or powered within the recommendations on the specification plate affixed to the boat.
4. Any boat has been subject to an accident, misuse or negligent use.
5. Damage to the boat as the result of improper support or incorrect adjustment of a road trailer.
6. Any boat used for racing or operating contrary to any written instructions provided by Senator Boats Limited. If the boat is used commercially a 3 year warranty applies.

Senator Boats 2017 Ltd accepts no responsibility for the following, which are excluded from this warranty:

1. Maintenance or expected wear through normal use.
2. Damage to upholstery by tearing, ripping, solvents or punctures.
3. Damage (including corrosion) to boat hull and or components caused by either poor quality vinyl wrap or vinyl wrap that is not installed to 3M standards and guidelines.

Under this warranty the obligation of Senator Boats shall be limited to replacement or repair of any part which Senator Boats judges to be defective.

Senator Boats will not be liable for any other special or consequential damages or costs of any kind or nature.

Senator Boats Limited reserves the right to change specifications and designs of any boat without assuming any obligation to modify any previously manufactured boats.

Nothing in the warranty limits or restricts a statutory right or remedy available to you under the Consumer Guarantees Act 1993.

For the warranty to be valid the boat's warranty registration card must be completed and returned to Senator Boats Limited within 14 days of the purchase date.

Care and Maintenance

To enhance the life of your vessel it is important to follow regular maintenance steps;

The vessel must be rinsed both internally and externally, including side pockets and under the fuel tank, after use with fresh water to remove salts, this preventing salt encrustation due to evaporation of sea water. If necessary, a non-etch cleaner and non-metallic scouring pad can be used to remove adherent surface grime and salt encrustation. It is recommended that you use a wax based car wash NOT detergent for washing your boat.
